RE: Parent Selection of Remote/Virtual Learning for September 2020

DATE: July 29, 2020

As you know, as of September 2, 2020, the DLCs will be open daily, Monday through Friday, on an abbreviated schedule for all students from 8:45 a.m. – 1:00 p.m. until the pandemic has subsided sufficiently to warrant a full day of instruction. In addition to this onsite option for instruction at DLC daily, Governor Murphy has approved an option in which all parents may choose to have their child learn remotely at home for the 2020 – 2021 school year during the pandemic. For your convenience, we are providing you with a copy of “[Clarifying Expectations Regarding Full-Time Remote Learning Opportunities for Families in 2020 – 2021](#),” which provides guidance about the fully remote/virtual online learning instructional program.

We request any parents who wish their child to have a fully remote/virtual online learning program at home in September to please complete the form [online](#) or complete the attached form via email at remotelearningoption@mu-jc.org, via fax at 908-464-1244, or via U.S. mail at Remote Learning Option, Morris-Union Jointure Commission, 340 Central Avenue, New Providence, NJ 07974 no later than August 5, 2020. In addition to emailing the form to you, you will also receive it via U.S. mail and it can be found on the [MUJC website](#), Facebook, and Twitter. If you choose the completely remote/virtual online learning program at home option for your child, your DLC principal will contact your sending district’s IEP team so that they are aware of your decision.
