Dear MUJC Parents and Staff:

We have been notified that an individual at the DLC-Warren has tested positive for COVID-19. The individual was not on the premises during the infectious period and had no contact with DLC students or DLC staff members. Therefore, there is no need for DLC students and staff to quarantine. The Warren Township Department of Health has been contacted. The individual who tested positive is self-isolating. Please be aware that due to confidentiality concerns, we cannot answer any specific questions about the individual.

We understand the level of concern regarding COVID-19. We encourage parents, students, and staff to continue following the Centers for Disease Control & Prevention promoted safeguards, such as:

- Staying home when you are sick;
- Washing hands often with soap for at least 20 seconds;
- Covering coughs and sneezes and properly disposing of tissues;
- Limiting close contact with people who are sick and not sharing food, drinks and utensils;
- Practicing social distancing (staying at least 6 feet apart);
- Wearing a face covering;
- Stay home and isolate if waiting for COVID test results; and
- Continuing to monitor your health for symptoms.

As always, we appreciate our community's support and cooperation. You can assist us by remaining vigilant in your approach to dealing with this health concern.
